Student Suspension and Exclusion Policy

In accordance with the School Act, Sec. 85(2)(ii) and (d), the Board authorizes the Principal or designate of any school in the district to suspend a student from attendance at school for up to five days.

Suspensions may be for the following reasons:

- A. because a student is willfully and repeatedly disrespectful to a teacher or to any other employee of the Board carrying out responsibilities approved by the Board.
- B. because the behaviour of the student breaches the District Code of Conduct or policy and/or has a harmful effect on others or the learning environment of the school.
- C. because the student has failed to comply with the School Code of Conduct.

Suspensions over five days are made in consultation with the appropriate Director of Instruction as per District Policy (http://www.vsb.bc.ca/district-policy/jgd-r-district -student-code-conduct-regulation)

The cited behaviours above are examples only and not an all-inclusive list.

The Parent or Legal Guardian will be asked to return with their child to make a commitment to improve behaviour.

Please note that if there is a violation of a very serious nature, suspension will be immediate.

Parents of offenders and victims will be contacted as soon as possible School District officials, police or other agencies may also be notified as required by law.

Consequences for Misconduct

Expectations of personal responsibility and consequences will increase with consideration given to a student's age and prior behaviours. Special considerations may apply to students with a disability of an intellectual , physical, sensory, emotional or behavioural nature. A restorative focus is our goal wherever possible.

Step 1:

The supervising staff member will speak directly to the child. A period of 'time out' may be required to reflect on decision-making skills.

Step 2:

The staff member may arrange to see the student to discuss and participate in restorative processes,

Step 3:

Staff will work co-operatively with students and parents/ guardians to come up with a plan to promote positive conduct.
