CAPITAL BYLAW NO. 2023/24-CPSD39-01 CAPITAL PLAN 2023/24

WHEREAS in accordance with section 142 of the *School Act*, the Board of Education of School District No. 39 (Vancouver) (hereinafter called the "Board") has submitted a capital plan to the Minister of Education (hereinafter called the "Minister") and the Minister has approved the capital plan or has approved a capital plan with modifications,

NOW THEREFORE in accordance with section 143 of the *School Act*, the Board has prepared this Capital Bylaw and agrees to do the following:

- (a) Authorize the Secretary-Treasurer to execute a capital project funding agreement(s) related to the capital project(s) contemplated by the capital plan or the capital plan with modifications;
- (b) Upon ministerial approval to proceed, commence the capital project(s) and proceed diligently and use its best efforts to complete each capital project substantially as directed by the Minister;
- (c) Observe and comply with any order, regulation, or policy of the Minister as may be applicable to the Board or the capital project(s); and,
- (d) Maintain proper books of account, and other information and documents with respect to the affairs of the capital project(s), as may be prescribed by the Minister.

NOW THEREFORE the Board enacts as follows:

- 1. The Capital Bylaw of the Board for the 2023/24 Capital Plan as approved by the Minister, to include the supported capital project(s) specified in the letter addressed to the Secretary-Treasurer and Superintendent, dated March 9, 2023, is hereby adopted.
- 2. This Capital Bylaw may be cited as School District No. 39 (Vancouver) Capital Bylaw No.2023/24-CPSD39-01.

OBJECTIVE: Improving stewardship of the District's resources by focusing on

effectiveness, efficiency, and sustainability.

INTRODUCTION

This report contains a recommendation for the Board of Education to consider whether the Queen Elizabeth Annex site is surplus to educational needs of the district.

BACKGROUND

In June 2022, the Vancouver School Board (Board) decided to close Queen Elizabeth Annex (QEA).

At its' November 28, 2022 public meeting the Board announced that an engagement process would be undertaken "to consider the potential declaration of the QEA site as surplus to the educational needs of the District".

ANALYSIS

Following the November 2022 announcement, District staff presented a <u>report</u> about the surplus considerations and engagement process at the <u>January 18, 2023 Facilities Planning Committee</u>.

As part of the surplus consideration, and as per Policy 20, the Board directed the District staff to engage with stakeholders, local governments, community organizations and/or the public in advance of the Board making any decisions regarding the future use of the QEA site.

Detailed information on the engagement process undertaken and the engagement findings were outlined in the <u>Queen Elizabeth Annex Surplus Consideration Engagement Report</u>. This report was presented at the April 5, 2023 Facilities Planning Committee Meeting. Stakeholder representatives provided input and feedback on the report. Also, on April 5, 2023 the Board held a Special Board Delegation meeting to receive feedback from members of the public on the possible surplus





consideration of the QEA site and buildings. Twenty delegations presented at the meeting, seven of whom provided PowerPoint presentations, which have now been forwarded to Trustees for their review.

SUMMARY

As per the requirements of Board Policy 20, the district has now completed the process for consideration of whether the QEA site is surplus to the district's future educational needs. The recommendation below is presented for the Board's deliberation.

RECOMMENDATION

IT IS RECOMMENDED that the Board, as per Policy 20 section 3.1, declare the QEA site and buildings (the Real Property) surplus to the needs of the School District and instruct staff to proceed with the Real Property disposal process.
